#### MEMORIAL SERVICE

To honor the deceased Brethren, the names were read for each state, and a State representative lit a candle at the altar in their honor. After all Brethren had been honored, a very Special Prayer was then given in their remembrance.

#### KEY NOTE ADDRESS

Brother Ercil Eschbach, PSP and International Sergeant At Arms gave a warm welcome and thanked everyone for their attendance. He gave a short message on Masonry and thanked High Twelve International for the opportunity to address the General Assembly.

#### GENERAL SESSION:

#### ROLL CALL OF OFFICERS

At the Past President's meeting, they voted to call for a Special Audit Committee to review expenditures for the past year and beyond if required. Several questions have to be answered regarding certain expenditures. The Acting President asked for volunteers to serve on this committee and the following members volunteered: Ercil Eschbach (CA), Don Whistler (PA), Loyd Smith (TX) and David Jacobs (NJ) will service as an alternate. The International Secretary and International Treasurer will serve as advisors. M/S/P to approve this committee.

The Treasurer, Ralph Clemmer, and Don Galway who served on the Committee to rework the budget yesterday presented the new budget to the membership. The budget presented had a surplus balance of nearly \$6000. There was a M/S/P to move \$5000 to a line item to pay the Wally Fund back \$5000.

After a very long discussion on income and expenditures a motion was made to accept the new balanced budget. M/S/P.

#### REPORT OF STATE PRESIDENT'S ROUND TABLE MEETING –

Endowment Fund Trustee – Loyd Smith gave a very detailed report and explained the \$16,000 withdrawal from the fund.

Credentials Committee: Richard walls announced the total votes, delegates and Masonic representative, and the number to elect.
