#### **International 1st Vice President**



By Donald M. Whistler: The annual convention of High Twelve International is only a couple of months from now. I have been thinking for some time about my plans for my year as your President, should I be fortunate enough to be elected to the position at the annual convention in June. I would like to share those plans with you. They cover two major areas, fundraising and club expansion/membership development.

In the area of fundraising, after going two years of not mailing the pocket planners on a timely basis or not mailing them at all,

we resumed mailing them two years ago. The first year, we had a loss of approximately \$300.00. This past year, we realized a profit in excess of \$1,800.00, excluding some miscellaneous expenses. I know that there are some of our members who believe that the time of the hard cover pocket planners has passed us by. To some extent, I believe that is true but, given the average age of our members, I also believe that the majority of them still use them. I plan, therefore, to recommend to the Executive Committee that we do the pocket planner project again this year and have a target date of the end of August for mailing them.

In addition to the pocket planners, I would like to do a project of mailing name and address labels with the High Twelve logo on them to our members. These are the labels most of us use for our return address when we mail letters. They have not been mailed to our members for sometime. Our President, Sid Leluan, introduced me to the vendor, who prints and mails them, at the Conference of Grand Masters. He is the same vendor who produced them previously for High Twelve International. If the Executive Committee agrees to it, I would like to do a mailing of the labels in February or early March 2013. We will need to have our data base in good shape for this project because the vendor will be using it for the printing and mailing of the labels for and to our members.

Now, I am going to cover club expansion and membership development. I am planning on dividing these objectives into three areas of responsibility. Our President, Sid, has made good progress in International Club development with his efforts in Mexico and the Philippines. He has also made excellent progress with Hawaii but that is one of our states. I am going to ask Sid to continue these efforts as he travels and has the opportunities to discuss High Twelve in other countries.

Another area is opening dialogue with the Grand Lodges of those states, which do not have any High Twelve Clubs at this time, about High Twelve. There are 30 of them! I do not know how long it has been since there was a concentrated effort with these states so I want to put forth an effort of doing it. At the Conference of Grand Masters, Sid and I had opportunities to talk with Grand Officers and Brothers from a number of these states. We both felt that there was definite interest in High Twelve. We need to

work at it and I plan to take on this effort as your President. The timeframe will be to make initial contact with the Grand Lodges by September 30<sup>th</sup> of this year with follow up as appropriate depending on the response of each Grand Lodge.

The third area of responsibility is club expansion and membership development. Each state in which we currently have clubs has lots of opportunity for the expansion of clubs. In addition, there is more information and material which we can be providing our existing clubs to help them increase their membership. Ask yourself these questions:

- 1. What are we doing for our members?
- 2. Do they know what High Twelve International has available for them?
- 3. What are we doing to help them grow their memberships?
- 4. Are we encouraging them to reach out and help open new clubs in neighboring towns or cities?

I am going to ask our three Vice Presidents to collectively develop a plan to address these objectives. The timeframe will be to have a plan developed by December 31<sup>st</sup> of this year for implementation in early 2013.

Finally, in an effort to establish better communication with our state associations and local clubs, I plan to establish regions or zones similar to those established for the Wolcott Trustees. One of our International Officers will be responsible for each zone. The configuration of states within a zone will have to be a little different than those for the Wolcott Trustees since we will not have as many officers to cover them but you get the idea.

#### **International 2nd Vice President**



By James Parker, IV: As we go to press, there is still much to be accomplished toward the goal of recreating High Twelve International into an organization that delivers great service and leadership for our collective future. A great deal of TEAMWORK is required to accomplish much of anything.

Also, in my roll as a State Secretary, I am amazed at just how much cooperation I get from Club Secretaries just for the asking. As you know, a current and correct membership "Data Base" is as important a tool as any in our toolbox. Just how

State Association and Independent State Secretaries, your continued help is needed to ensure that past and present per capita dues are brought up to date and remain that way. In accordance with the International Bylaws, State Association Secretaries are to send, to the International Secretary, on a monthly basis, the number of club members they have, and break it down to iden-

tify the ACTIVE versus those in a Masonic Home, because they are charged at a different per capita amount. In addition, the membership listing of each club, as currently shown on the International database, has been provided to each State Association Secretary. These individual club listings need to be reviewed and updated as necessary so that accurate information is currently reflected. These updated membership club listings are to be sent to the State Association Secretary and from him to me. A reminder, current per capita dues, for the 2012/2013 year, are figured on the FEBRU-ARY 2012 number of club members NOT the December 2011 monthly membership club report! It is important to note that, in accordance with the International Bylaws, Article IV, Section 9A(2), "Any club delinquent in payment of per capita dues for any billing cycle to International shall NOT be entitled to vote on any matter coming before the International Convention and its proxies are void." Please be sure to pay whatever per capita dues are owed prior to the June 2012 International Convention.

#### **International First Vice President**



By Donald M. Whistler: The more I learn about the Wolcott Foundation, the students it supports for graduate degrees and the George Washington University, the more pride I feel in High Twelve's support of it.

Recently, our President, Sid Leluan, and I were fortunate enough to be invited to attend the annual meeting of the Wolcott Foundation Trustees Selection Meeting in Washington, D.C. First, I want to compliment the Trustees for their hard work during their two days of meetings. They had 142 applications for Wolcott Fel-

lowships, which they each reviewed and prioritized before coming to the annual meeting. They then collectively worked during the sessions to narrow the applicants down to the top 25 applicants. The top 10 of the applicants will be mailed letters informing them of their selection for Wolcott scholarships. The remaining applicants will be held in reserve but will be informed of their status. The objective of the Trustees is to receive the acceptance of the Fellowships from seven or eight applicants.

During the three evenings and two days of the annual meeting, George Washington University hosted several events, which gave us the opportunity to meet graduates of the program, current students and faculty, including the Deans of the Trachtenberg School and the Elliot School. They all are very appreciative of the financial support provided to the Wolcott Fellows by the Wolcott Foundation. One of the graduates even drove Sid and me to a meeting of the D. C. Club where he was the speaker for their meeting. We certainly can feel pride in the graduates of this program.

Finally, I had been previously asked about the areas of study which are available a student once he or she is selected for a scholarship and I now have a much better answer to that question. There are three areas of study available to them. These are, as follows:

- School of Business "is cognizant of the deep ties between business and society and the intricate relationship between business and politics." "It emphasizes and incorporates ethics, sustainability, corporate social responsibility and a global outlook at every level."
- Columbian College's Trachtenberg School of Public Policy and Public
   Administration "boasts top-ranked graduate programs that are educating tomorrow's analysts, leaders, managers and researchers in the public and nonprofit sectors."
- 3. <u>Elliot School of International Affairs</u> provides "the study of international affairs" and an "understanding of the world's challenges and opportunities." "More than three-quarters of the graduate students go on to careers in public service or the nonprofit world."

It is my understanding that the majority of the Wolcott Fellows attend either the Trachtenberg School of Public Policy and Public Administration or the Elliot School of International Affairs. They are committed, after graduation, to four years of employment in governmental service, in international affairs or in selected international business in the private sector before pursuing a different career. Many of them continue in these types of services.

**Wolcott Foundation News** By Malcom S. White, Chairman, The Wolcott Foundation, Inc.: Brother High Twelvians, Wolcott Foundation Members; your Foundation Trustees met recently in Washington, D.C. to select the Wolcott Fellows, Class of 2014. The Trustees were able to fund five Fellowships this year, due to the return on the Endowment Investment Fund, and not, sad to say, due to the donations from High Twelve members.

The contributions for the Wolcott Year were only enough to fund about one half of a Fellowship. It is a fact that the economy is not what we would want it to be, but the fact remains that High Twelve has made a commitment to make available well trained

As approved at the 2012 Mid-Winter Conference to be voted upon at the 91st Annual Convention June 24-27, 2012.

## RESOLUTION: ONE 2011-2012 AUTHORITY and RESPONSIBILITY of STATE ASSOCIATIONS

**Whereas:** our State Associations were created to improve the interaction and intercommunication of Clubs within a well populated Jurisdiction, and

**Whereas:** there is no authority granted or Responsibility given to the State Association by High Twelve International for the development of High Twelve in that Jurisdiction, and

**Whereas:** the worldwide growth of High Twelve International is creating an ever increasing need for more local nurturing than can be reasonable expected of its International Officers, and

Whereas: there is no authority to actually assist Clubs in their State Association and

Whereas: there being no authority to ask a club to do anything and

**Whereas:** a more local authority (State Associations) would be better enabled to work more closely with the growth and retention of High Twelve in the local area, and

**Whereas:** the International Secretary has an ever increasingly difficult challenge for creating/providing records for dues collection and membership fluctuation

**Whereas:** High Twelve International has no provisions for State Association to perform or assist in performing any such duties as:

- 1. International Per-Capita collection
- 2. Other duties as may evolve

**Therefore be it resolved:** that under the current rules for forming State Associations, once formed they be granted full authority to:

- 1. Be an interface between High Twelve International and their Jurisdiction's respective Clubs.
- 2. Be an interface for communications to and from Clubs, normally passing through the State Association Secretary.
- Create officer positions as necessary to develop High Twelve in their Jurisdictions.
- 4. Divide the Jurisdiction into manageable Regions, under the direction of Regional Vice Presidents, for a closer working relationship within that Jurisdiction.

- 5. To create new Clubs in their Jurisdiction.
- 6. Charters for new Clubs would still be generated by High Twelve International
- Collection of Per-Capita dues for both their State Association and High Twelve International would be a function of the State Secretaries, working closely with the International Secretary.
- 8. If necessary, request assistance from High Twelve International in assessing corrective action in matters of a Club's non-conformance to High Twelve International's Constitution and By-Laws and/or the Association's By-Laws.

#### RESOLUTION: TWO

#### **DIVISION of HIGH TWELVE INTERNATIONAL INTO WORKABLE REGIONS**

In looking at the potential workload of International Officers, there is a strong need to spread the work around so the President does not feel the need to do it all.

One potential project to accomplish this end would be dividing the State Associations into REGIONS. Each International Vice President would be assigned the assistance of Associations in his assigned Region. The following support is offered:

**Whereas:** The complexity of a growing organization creates a need to change the way we do business, and

**Whereas:** There are currently 15 Association as well as several independent Clubs in existence, and

Whereas: A consistent level of services is not seen at all Jurisdictions, and

**Whereas:** More than one International Officer many visit the Annual meeting of a specific Association, not knowing the others were also attending, and

**Whereas:** While in the performance of his duties, the International President is free to travel anywhere in the world to develop High Twelve International.

**Therefore be it resolved:** That the International President be changed with dividing the Associations into workable Regions. This division should be designed to reduce necessary travel to accomplish better service to our clubs, and

**Further be it resolved:** That the International President be charged to assign the International Officers as Regional Directors of one of these Regions:

 Regional Directors would be responsible for travel within his Region, attending Annual Meetings, and other special events

## RESOLUTION: THREE CLUB MERGERS, CONSOLIDATIONS and CESSATIONS

The only language found in our documentation regarding clubs who go out of business is found in the "Club Officers Manual" page C5. (C – Termination of Membership of Clubs in High Twelve International, SECTION 4, 5, and 7) states the surrender of everything back to High Twelve International.

That is: Charter; Banner; Bell; Records; MONEY

Support for the need to amend the Club Officers Manual is:

**Whereas:** Our past practice for handling, Mergers and Consolidations is inconsistent with our practices found in the Club Officer Manual.

**Whereas:** In Mergers and Consolidations, the Charter, Bell and possibly Banner are no longer of any use to the Clubs, the money would be useful and should rightfully stay with the Merger and Consolidation. And

**Whereas:** our past practice is the allow the money and possibly Banner to stay with the surviving Club, And

**Therefore be it resolved:** A process needs to be developed for the International Club Manual outlining the steps necessary to Merge or Consolidate. These steps may include:

- A formal contact (letter, phone call, e-mail) sent to the State Association.
   Understand this step is not completed until a response is received from the
   State Association. A phone message or blind e-mail will need follow-up to
   establish contact.
- 2. The State Association officers then engage in discovering a root cause and possible aversion of loosing a Club and/or its members.
- 3. The Charter, Bell and Banner are to be returned to High Twelve International upon completion of the Merger /Consolidation, unless for cause other arrangements are made.

## RESOLUTION: FOUR 2011-2012 UNIFORM BY-LAWS FOR CLUBS and ASSOCIATIONS

This Legislation is provided to eliminate the sometimes voluminous and unnecessary Constitutions and By-Laws each Club and Association currently have on file. Also, and more importantly, the elimination of the possibility for having conflicts with the operation rules of High Twelve International. This is in no way intended to prohibit Clubs and Associations from establishing resolutions for their specific Club/Association. (ie Scholarships etc.). Toward this end we offer the following support:

**Whereas:** our constituent Clubs and State Associations are created and Chartered by High Twelve International, and

**Whereas:** High Twelve International provides its Constitution and By-Laws designed to provide the governing structure for our operation, and

Whereas: ample manuals are provided for Clubs and Associations to operate their Club/Association, and

**Whereas:** due to their subordinate attachment to High Twelve International, our Clubs and Associations need only supply a small amount of information to establish this attachment, and that information be:

- 1. Name of the Club/Association
- 2. Mailing address for the Club/Association
- 3. Place (establishment name and address) where the Club regularly meets
- 4. Establish Stated Meeting dates, including provisions for alternate dates when said Stated Meeting falls on a holiday, inclement weather or other unavoidable situation.
- 5. Establish the dates for officer nomination, election and installation

**Therefore be it resolved:** That a Uniform set of By-Laws be created. Also, that each Club and Association complete and return a copy of this fill-in-the-blank form.

## RESOLUTION: FIVE 2011-2012 ELECTION of INTERNATIONAL SECRETARY

This Legislation is provided to convert the office of International Secretary from an annual appointment by the President to an elected position. Also, and more importantly, the reduction of a potential for "conflict of interest" made by the close association of the President and Secretary. This is in no way intended to speak poorly of any International Secretary past, present or future. Toward this end we offer the following support:

**Whereas:** to promote a position that is consistent with other Grand Bodies and especially International Officers (Treasurer), and

**Whereas:** all Elected Officers have the opportunity to participate in an exchange of questions and answers during the Annual Caucus meeting, and

**Whereas:** a potential "conflict of interest" can exist when ever an appointed position is to closely tied by his appointing officer, and

**Therefore be it resolved:** That election of the International Secretary is preferable, there will be an annual election for the office of International Secretary at each Annual Meeting of High Twelve International.
