- Roll call by Kevin Hokerk-Robinson
 - o There was a quorum of the governing board present 18 members with in attendance
 - o There were 8 PIP's present
 - Total of 36 votes or 17 votes for a simple majority contested votes will be settled with a paper ballot utilizing credentials voting procedures.
- The 2017 Mid-Year Minutes were M/S/P as published in the report packet (Hewitt/Whistler)
- Correspondence Kevin Hokerk-Robinson, Secretary
 - o There were no resolutions
 - There was one HTI Bylaws amendment related to New Clubs and per-capita and will be taken up under new business
- International Officer's Reports
 - o In addition to the printed reports
 - 1st VP Haynes described the Replace Yourself program and the base pin and triangle pins
 - 2nd VP Santisteban talked about Prince Hall and the efforts to gain a club or two there should not be any restrictions between the two Grand Lodges in IL and similar in TX

- 3rd VP Dilley we recently took in 3 members that were 19-20-year old's! Here I am at 40 and representing the hope of youth. I will be attending DeMolay International and Job's Daughter's Grand Sessions. It is amazing how absent Mason's are at these sessions.
- President Woods there has been an interest in possibly 7 new clubs in FL new club kits are in the works to Michael Hemphill. I have been working in Southern IN and KY.
- Secretary Hokerk-Robinson the lack of Monthly Reporting hurts us when not done. REF; page 14 to see the filing frequency of club filings – 40% do not file and have not filed for multiple years. The process has been made as simple as can be.

Committee Reports

- o In addition to the printed reports
 - Wolcott Foundation Michael Clark, Chairman The Trustee's have been listening and the WF manuals, procedures and documents have been or are being revised. Donations received that are less than \$100 go to the Fellowship Fund, donations over \$100 go to the Scholarship Fund. The WF bylaws will be reviewed over the next 6 months and presented as prescribed for approval at the next convention. A full 40-hour scholarship will rise to \$72,000 in 2018. The minimum GPA for applicants was raised from 3.75 to 3.80. 1/3 of applicants don't meet qualifications. 2 fellowship awards will be made for the fall 2017 term. We are the oldest fellowship being awarded at GWU. We are also looking for outside corporate fundraising opportunities. The GWU Deputy Provost, Theresa Murphy will be speaking to us at the luncheon tomorrow along with Sherry Rusneck a 1989 Wolcott Fellow. Mike then issued a \$20 challenge for donations, and his youngest son, who works for Cobalt Tools, is giving an autographed emergency tire compressor to sweeten the deal. \$472 was donated and Winton Hewitt won the compressor.

- WF Donations by Zone/Club for the current year Robert Morton, WF Treasurer. We provide the report to the HTI Secretary for publication/posting. Donations need to come in timelier, so it can be invested to work. Bob reviewed the financials for the fiscal year. A note was read from Malcolm White. The Wolcott Century Club/Wolcott Club donation awards were explained.

- Old Business

- Non-responsive/inactive associations
 - Missouri Association closed on 1/14/17, received checking funds, waiting on a CD
 - New Jersey Association closed on 1/11/17, received checking funds, property of the association "lost" in transit, but sender can not provide any receipts or tracking numbers for the shipments
 - Louisiana is non-responsive and has no officers
- Per-capita status:
 - 2015-16 6 clubs delinquent for \$1,130.00 outstanding NO VOTE at this convention
 - 2016-17 20 clubs delinquent for \$3,014.00 outstanding NO VOTE at this convention
 - 2017-18 68 clubs outstanding for \$15,158.00
 - Why haven't the club charters been pulled? Because we hope they will pay. The six clubs have received registered, return receipt and no responses received. MI, we have no authority to make a club do anything. We are playing the nice guy, but it has not work. The bylaws state 18 months delinquent charters are pulled automatically.
 - It was M (amended)/S/P that the secretary "A letter to be written to all clubs and membership thereof who's annual per-capita has remained unpaid since 2015 stating that their charter will be automatically suspended in thirty days unless arrears are paid to the international secretary. Reference HTI bylaws, presented by Jerry Hamilton.
 - Bottom line the clubs (and associations) are business and the elected officers have inherent responsibilities that go with their office. Club monies should be in a club account not someone's personal account AND there needs to be more than one "live" persons signature on the account signature card.
- Only 4 of the 13 Associations responded for the annual officer and club validation request
- o Group Exemption Annual Validation
 - Validation ignored by 9 associations
 - Updates were filed with the IRS on 2/24/17
 - IRS responded that updates were completed 6/1/17
 - Clubs with non-profit status revoked can not be added to the group exemption and must file the paper 990-N EZ tax form annually.
- O HTI being incorporated Arizona at the last mid-year it was approved to register as a foreign corporation doing business in AZ this would allow us to do signature changes etc. The paper work was filed and rejected because there isn't a registered agent in MO and it is impossible to do per the MO Secretary of State Office as being a perpetual non-profit there are no officer filings. That said the secretary moved that he be allowed to file HTI in AZ as a non-profit organization 501(c10) for banking purposes. The motion was approved.
- Database the 2-year pre-pay at Wild Apricot expires on 6/17/17 and the renewal for 1 year is set at \$2,592.00. Access databases continue to be used for Club Officer, EIN, Per-Capita, Form/Merchandise ordering and Fundraising.
- o 14 PayPal payments were received for labels, pocket planner, general support and \$100k Endowment fund minimal use. It will not be utilized for per-capita payments because of the fees involved
- o The website was upgraded to HTTPS meaning it is now a 'secure' website with the green padlock
- President Woods:
 - Dress tonight is business dress, not casual
 - Communications to have a Wolcott representative on our monthly conference calls and we
 have a representative on their calls excluded would be just internal meeting discussions. This
 would keep the door open for future discussions.
 - Get out there and talk to your Prince Hall members

- Indiana Prince Hall is having their annual communication in July and I would like to have a table there to spread the word about High Twelve if the PHGM will allow it

- HTI needs to establish a goal in establishing 20 new clubs per year for the next 5 years
- Jerry Saville announced the PIP breakfast tomorrow morning at 7:00 AM and there are 8 PIP's present this year. I have been waiting for 4 years to make this announcement! Don Whistler stated the senior PIP runs the meeting and the Junior is the secretary.
