HIGH TWELVE INTERNATIONAL, INC. – VIRTUAL CLUB BYLAWS

ARTICLE I – STATEMENT OF OBJECTIVES

- A. The name of this Club shall be the **President’s Virtual** High Twelve Club, Number **1002** (hereinafter “Club”).
- B. As a virtual club, there isn’t a physical meeting location, therefore the address of the club shall be the current location of the International Home Office.
- C. It holds its Charter from, and owes fealty and allegiance to the High Twelve International, Inc. and shall act in accordance to the Constitution, Bylaws and Rules adopted by High Twelve International, Inc.
- D. The principal objects of this Club shall be:
 - a. As a means to join High Twelve International where there are not clubs currently located;
 - b. to inculcate the ideals taught in Masonry;
 - c. to support the Wolcott Foundation, the principal philanthropy of High Twelve International Inc.; and,
 - d. To give support and attention to the youth of America, fostering, encouraging and enthusiastically supporting their moral, social and intellectual development.
- E. The members of this Club acknowledge the supreme authority of the Grand Lodge of their official home residence in all matters of Masonic law, tradition and ethics. The members pledge never to interfere with or meddle in the affairs of any Masonic Lodge, nor to engage in, nor sponsor, any activity prohibited by said Grand Lodge; nor to engage in unseemly conduct which might reflect adversely upon the institution of Masonry.

ARTICLE II – MEETINGS

There shall be no stated meetings of this club however, members are encouraged to attend all duly called meetings of High Twelve International.

ARTICLE III – OFFICERS AND COMMITTEES

- A. **President**. The current President of High Twelve International shall be the designated President for the length of his term of office.
- B. **Secretary**. The current Secretary of High Twelve International shall be the designated Secretary for the length of his term of office. It shall be the responsibility of the Secretary to: receive requests for membership, reporting membership and other changes on the Monthly Reporting method currently in effect; issuing membership certificates and dues cards; to serve as custodian of all official membership records; to announce the call for all International Meetings to the membership.
- C. There shall be no other officers.

ARTICLE VI - GOVERNANCE

ARTICLE VII - MEMBERSHIP

- A. To be eligible for Regular membership, candidates must be a Master Mason in Good Standing in a regularly constituted Masonic Lodge in a recognized jurisdiction.
- B. To be eligible for Masonic Home membership candidates must be a Master Mason of a regular Masonic Lodge in Good Standing and be a resident of a Masonic Home.
- C. Membership of any Member shall be terminated upon:
 - a. Failure to maintain membership in Good Standing in the Blue Lodge.
 - b. Failure to pay annual dues or charges due to the Club after thirty (30) days electronic notice of delinquency;
 - c. Conviction of a felony or other criminal charge which would bring disgrace or disrepute to Masonic principles.
- D. Reinstatement: Regular and Masonic Home Membership - former Regular and Masonic Home Members may be reinstated to the membership upon his petition, reinstatement fee, and the payment of all his indebtedness to the Club.

ARTICLE VIII - FEES AND DUES

- A. New or Reinstated members shall pay the current fee in effect by High Twelve International.
- B. The dues shall be set at the current rate of the High Twelve International Per-Capita in effect.
- C. The fiscal year of the club shall coincide with the High Twelve International Per-Capita year.

ARTICLE IX - LOCAL REGULATIONS

- A. Not applicable.

ARTICLE X – TERMINATION OR DISSOLUTION

- A. In the event this Club shall cease to exist the membership will be informed by electronic means.

ARTICLE XI - CONFLICT DISCLAIMER

Anything contained in these By-Laws in conflict with the Constitution and By-Laws of the High Twelve International, Inc. is hereby declared null and void.

ARTICLE XII - CLUB FUNDS

All Club funds shall be kept in the name of High Twelve International - General Funds; Per-Capita, in a financial institution in which the funds are federally insured (such as F.D.I.C. etc.).
