
She spoke about the Frauds and Scams being perpetrated against Seniors

#### THE HOLY BIBLE

Freemasons revere these Holy Writings as our rule and guide for how we should live a life of morality. To us it is one of the Three Great Lights along with the Square and Compasses. No lodge meeting is to be opened until the Three Great Lights are properly and respectfully arranged on the Masonic Altar, slowly and with at least as much reverence as is given to the Flag of our Nation. This reverence varies by the individual Brother in the ways he has been taught or by means of his sincere devotions. Some place their right hand over the heart, others with the right and left arms crossed across the vital life

organs, the chest. The Lodge Master should remove his head covering, if one is worn.

By some understanding of the Bible's history we can better understand why it is so revered. And we're not only free to read and study its contents, we're strongly encouraged to learn and practice the lessons that are to be found in those great book of 66 books between the old and new testaments. It is by their lessons and those we obligated ourselves to as we swore to as we proceeded through the symbolic and age old Masonic foundation degrees.

The history of the Holy Bible appears to have had its start with the first of God's word being delivered to Moses in the form of the Ten Commandments, circa 1400 BC. We have no information of others until about 500 BC, when the Hebrew Manuscript of the 39 books of the Old Testament was completed. Then in about 200 BC, the Septuagint Greek Manuscript was completed. It contained the 39 books of the Old Testament and the 14 books (of uncertain and questionable authority).

Then we move into the AD dating. In about 315 AD, the 27 books of the New Testament were identified by Anthenasius, Bishop of Alexandria, which is recognized in modern times by most Christians as the accepted Authority of Scripture. By 500 AD, the Bible had been translated into more than 500 languages around the globe. But in about 600 AD the Catholic Church allowed only the Latin Language Bible, and the common man was forbidden to learn to read it, only the Church Authority was allowed to read and translate its meanings for teaching the people (mind control?)

It wasn't until about 995 AD that the Bible was translated into the early forms of the English language. Wycliffe hand wrote a manuscript copy of all 80 books. Then in 1455 AD, Gutenberg invented the printing press and the Bible could be printed in mass production. The first ones had to be printed in Latin for The Church. Then Myles Coverdale Bible was printed in the English Language. This Bible contained the 80 books, consisting of the Old Testament, the New Testament, and the 14 dubious Apocrypha books. In 1539, the Great Bible of 80 books was published for the general public.

I now submit that we should appreciate and revere those 66 great books, now that we know the history of its struggles, allowing us the liberties and encouragements to do so.

My first exposure to High-Twelve was when my Dad's boss 'borrowed me as his guest at a 'bring your son to High-Twelve' Meeting back in the early 1960's. (Brother Cliff Ecklund, CEO of a major mfg. company only had a daughter). This is relevant due to a distinct memory of that meeting. There I was, a 13 or 14 years old sitting among 40 or so dark-suited businessmen and professionals at lunch. It was a who's who of Dubuque, Iowa. Among the distinguished Brothers present (I learned later) was an attorney, Chuck Kintzinger, who became President of the Iowa Bar Association and Mayor of Dubuque, Richard Loetscher, CEO of Farley & Loetscher, at one time the largest wood-working plant in America and Brother Edwin Lyons, owner of five business colleges in Iowa and a major philanthropist.

The special memory was when they passed around a school house for the Wolcott and one apparent new member asked, who & what is this Wolcott foundation, why don't we give money to a 'real' charity?. I wondered that too as I certainly knew of the Red Cross, American Cancer Society et al but nothing called 'the Wolcott'. The response to the query came from a very earnest man who proceeded to give an impassioned explanation as to what the Wolcott was about, its uniqueness, etc. I did not see this respondent again until I was being Raised in Mosaic #125 @ Dubuque at age 24 - he was my Lodge Secretary. 
#### **Wolcott Foundation Treasurer Robert Morton, Trustee Zone 6:**
